**Canadian Cancer Society's Lodges**

In a province as geographically diverse as British Columbia, traveling a great distance to a cancer treatment centre is an unfortunate reality for many. Patients often arrive at the Canadian Cancer Society's Lodges feeling worried about their future and nervous about their procedures – all at a time when they are separated from the ones they normally rely on for support in the most difficult of times. For more than 30 years, the Canadian Cancer Society has found that providing a welcoming, caring environment in our Lodges helps meet the physical and emotional needs of those fighting cancer when they can't stay home. Lodges take away all the unknown factors of being away from home and serve as places of refuge and comfort.

The first Canadian Cancer Society Lodge was opened in 1980, after current solutions of boarding rooms and hotels seemed unsatisfactory. The Society acted on its promise of support to those on a cancer journey and the Vancouver Lodge, their first of our Lodges, was born. In 1982, the Vancouver Island Lodge was opened, and in 1998, the Southern Interior Rotary Lodge followed suit, both timed to open at the same time as new cancer treatment centres. In 2010-11, 5792 persons were admitted to our three Lodges. And in July 2011, we broke ground for the construction of a new Lodge in Prince George, planned to open in December 2012, to better serve the needs of Northern BC residents.

The impact our Lodges have on our guests and their families is significant. Our Lodges give comfort in a time of great upheaval, uncertainty and discomfort. The many thank-you notes we receive from grateful guests and their families tell us that the quality accommodations and programs at the Lodge are meeting a very real need:
